### In the year of the Monkey

Thoughts from the outgoing Chair of CENTR's Board of Directors, Giovanni Seppia



2016 is the year of the Monkey in the Chinese calendar. According to the Chinese Five Elements horoscope, Monkey contains Metal and Water. Metal is connected to the wind, which implies that the status of events may change very quickly. Water is connected to wisdom and danger, meaning that we may deal with more financial events in the year of the Monkey.

The IANA transition and ICANN accountability processes should be fast drawing to a close (or at least we all wish they did), the latter far from being a multistakeholder journey, both with a budget that has unfortunately exploded. We may all personally wonder how long it will take ICANN to produce well-structured and sound budget practices for any of their projects and/or actions, as strongly and regularly demanded by the ccNSO SOP over the past five years. 2015 ended with the ICANN family spread among 3 hubs and 6 engagement offices whose real value has not yet being properly investigated and that suffer from inconsistent policies. 2015 ended with 634 new gTLDs being launched and the start of the evaluation of the new gTLDs to assess if there is the need for a future round. The year also ended with the predictable renewal of the IGF mandate and the confirmation that inde-

pendent initiatives such as Netmundial, which duplicate existing community-based mechanisms, never go very far. 2015 was a busy year for the DNS community, and 2016 will be equally busy.

The founder of the World Economic Forum recently stated in Davos that we may replicate the human brain in a robot, but robots will never have the ability to believe in something. And I would like to leave you with an invitation to keep believing, believing we can further serve our stakeholder communities as we have done in the past decades, believing that we can and should continue to constructively contribute to the ICANN and worldwide Internet governance processes, believing that we can all work together within the friendly spirit that has distinguished the CENTR community since its dawn, believing that the digital revolution that started a long time ago may soon lead to a new human renaissance.

I enjoyed a lot being the CENTR Board Chairman in 2015. Not only because I had the honour to work with great Board members, but also because I saw the CENTR Secretariat further developing, coping with new challenges, rolling out the Communication and EU Policies that were presented to us not so long ago.

And with the enthusiasm of the staff newcomers, the expertise of those we have known for several years and under a very good leadership, I believe the Secretariat managed to achieve high-level goals, to strengthen the relations with most of us, and to become a true point of reference for the EU institutions and other DNS industry stakeholders. Therefore, I would like to warmly congratulate the Secretariat on behalf of the current Board. Thank you.

## New Board, new member welcomed and crucial topics covered at CENTR's 55<sup>th</sup> General Assembly

CENTR held its 55<sup>th</sup> General Assembly on 16-17 February 2016 in Budva, Montenegro. The meeting was well attended by 55 participants from 33 registries, and was kindly hosted by doMEn, the registry for the .me country code top-level domain (ccTLD).

The meeting was graciously opened by a keynote address from Vujica Lazovic, PhD, Deputy Prime Minister and Minister for Information Society and Telecommunications, Montenegro Representative on the Governmental Advisory Committee of ICANN and ccTLD Manager for .me TLD.

In addition to welcoming three new members to its Board of Directors as well as a new member to its community, participants got treated to a full agenda covering several issues of high interest to its membership. From a refresher on the IETF and special use of domains to registry liability, trends in domain name pricing, as well as several registry, CENTR secretariat, ICANN accountability and IANA transition updates, participants were not short on discussion topics.

Budva, 17 February 2016 – CENTR is happy to announce that it has elected its new Board of Directors at the association's 55th General Assembly in Budva, Montenegro. ### CENTR welcomes MARnet (.mk) to its community

On 17 February, MARnet's (.mk, .MKД) membership application was approved by CENTR's 55th General Assembly in Budva, Montenegro, bringing the CENTR community to a total of 62 full and associate members.

MARnet is the registry for .mk and .MKД, the country code top-level domain of the Former Yugoslav Republic of Macedonia (FYROM). The .mk ccTLD was established in 1994 within the Ss. Cyril and Methodius state university in Skopje. Since February 2011, the registry has been operating as an independent public institution. MARnet has also been operating the Cyrillic version of .mk (IDN) .MKД since 2014. It has more than 25,000 domains registered under .mk and more than 600 domains under .MKД.

### The "new" Safe Harbour – Shield without protection

On 2 February, the European Commission proudly announced an agreement on the new EU-US Privacy Shield. For now, it is a list of "assurances", but no document has been seen. The main points: stronger obligations on US companies to protect Europeans' personal data, written assurance by the US and redress mechanisms. Read more

### The Apple Case – How privacy could look in the future

Apple has received a US court order obliging it to crack an iPhone used during the December massacre in San Bernardino, US. So far Apple has refused to "hack its own customers", arguing that such a move would endanger consumer privacy and security and open the door to criminals. Building a version of iOS that bypasses security (i.e. wiping out all data if a wrong password is entered more than 10 times) would be equal to creating a backdoor. Read more

#### GDPR - impact on ccTLDs

CENTR is currently analysing how the new EU data protection laws could impact ccTLDs. First results will be presented at the upcoming L&R workshop. In the meantime, read this Privacy and Security Law Report by Bloomberg Law for a comprehensive overview of the main clauses of the General Data Protection Regulation (GDPR) and its implications.

#### NIS Directive – where do we stand?

The final text of the NIS Directive still needs to be adopted by the European Parliament in plenary. Member States then have 21 months to transpose it into national law. Despite the fact that registries are specifically named in the Directive, this does not mean that they are automatically covered by its requirements. It is up to Member States to decide how critical an operator or infrastructure actually is. See the latest version (18 December 2015) and an overview of each EU institutions' position.

### 20% of Internet users affected by online security issues

This is the result of a Eurostat survey in 2015. Issues included viruses affecting their devices, abuse of personal information, financial losses, etc. This discouraged almost 20% of respondents from shopping online, using online banking (18%) or using WIFI if it was not their home connection. #### EuroDIG publishes a draft programme

The 150+ topic proposals have now been clustered and allocated to different session slots. CENTR and EuroISPA proposed a technical training workshop to explain how content control measures impact on the different layers of the Internet. The objective is to make this an independent side event in order to set the foundation for an informed debate with stakeholders on content control.

### Umbrella Agreement not compliant with EU law

In a recent opinion the European Parliament's Legal Service said that the EU-US Umbrella agreement, which concerns the transfer of EU data to the US for law enforcement purposes, does not comply with EU primary law and does not respect fundamental rights. Further reading: Euractiv




