

Next week, ICANN60 takes place in Abu Dhabi. The full schedule of this 7-day meeting is available <u>here</u>. Expect intense debates on the need to change the current **WHOIS** protocol and changes to the **registry-registrar agreements**. From a ccTLD perspective, the two important topics are the **use of country and territory names at the top level** and the Policy Development Process (PDP) on **retirement of ccTLDs**.

Policy Development Process (PDP) on retirement of ccTLDs

As previously reported, the ccNSO Council has decided to start a ccNSO PDP to develop and recommend policies on two related issues:

- 1. The retirement of country code top-level domains;
- 2. The review mechanism for decisions relating to the delegation, transfer, revocation and retirement of country codes.

These issues come down to two fundamental questions. The first one is: What happens to a ccTLD if the country it relates to changes its name or ceases to exist? (e.g. USSR or Yugoslavia). The second one is: What is the appeal mechanism if anyone disagrees with a decision from the ICANN Board? (e.g. refusal to add a new ccTLD to the rootzone)

The first step will be to develop a policy for the retirement of a ccTLD. The group will update the ccNSO on progress, there will be an educational session on the importance of the ISO 3166 list and how it is maintained, and the group will have a working session in Abu Dhabi following the ccNSO meeting.

The group is currently working on the framework to analyse the retirement cases to date. This work will take place in parallel with starting the discussion on the impact of the finite stage of a country code on the ISO 3166 list and in the context of the IANA practices. A finite state is when, for example, the name of a country changes, which impacts the two-letter code.



Country and territory names / codes at second level; geographic names

Discussions about 2-character country and territory <u>codes</u> at second level, country and territory <u>names</u> as second level domains, as well as <u>geographic</u> names at the <u>top-level</u> will continue. The new gTLD Subsequent Procedures PDP WG will form a fifth <u>Work Track (WT5)</u> dedicated solely to geographic names at the top-level. WT5 will have shared

leadership among GAC, ALAC, ccNSO and GNSO. The GAC has "conditionally" appointed Olga Cavalli (Argentina). However, for this to become formal, the GAC have to accept the WT5 terms of reference. Also, Olga Cavalli aspires to become new GAC Chair, and if elected, is unlikely to remain in that role. In their meeting, the GAC will discuss the role of its geographic names WG in WT5 as well as "alternatives for participation in WT5".

The ccNSO will be represented in the WT5 by Annebeth Lange (Norid) and Nick Wenban-Smith (Nominet).

Both APTLD and CENTR have already formulated their <u>position</u> on the issue:

- That CENTR members and others within the ccTLD community participate positively and constructively within Work Track 5;
- Based on CENTR members' past experience over many years, this is a complicated and contentious topic,
 and there is not an obvious consensus solution to the problems posed; and
- In the absence of any new consensus within Work Track 5, CENTR members believe that the current restrictions on registration of geographic terms as new gTLDs should be maintained, namely:
 - All 2-letter ASCII codes, whether or not they are currently in the ISO 3166-1 alpha-2 list, are reserved for exclusive use as present and future ccTLDs;
 - The 3-letter ASCII codes in the ISO 3166-1 alpha-3 list should remain blocked and ineligible to be applied for as a new gTLD, meaning that the vast majority of the 17,576 3-letter combinations are available for use as new gTLDs, but confusion with existing ccTLDs is mitigated; and
 - The compromise restrictions on registration of country and territory names as new gTLDs as set out in ICANN's 2012 Applicant Guidebook should be retained

It will be of the utmost importance that ccTLDs actively participate in this group. A <u>call for volunteers</u> has recently gone out.



Country and territory names / codes at second level; geographic names

The GAC will also meet with Amazon (the company) whose application for the top-level domain .amazon had been denied based on GAC advice (which put forward public policy concerns strongly voiced by the Brazilian and Peruvian governments). Amazon sought independent review of the ICANN Board's decision. The Independent Review Panel (IRP) issued a <u>final declaration</u> on 11 July 2017 calling for the Board to "promptly re-evaluate Amazon's application", asking for an "objective and independent judgment" of public policy reasons, and requesting that any future decision about how it proceeds with the application be explained (s.a. <u>Board Resolution</u>, 23 Sept 2017). The case is interesting for the GAC, ccTLD and gTLD communities: it exemplifies policy and process with regards to a name that the GAC would like to see protected as "territory" (whereas it does not fall under the ISO-list), but that also refers to a brand with strong recognition.

Data protection and privacy

The GAC will continue discussions around WHOIS reform and the impact of the GDPR on ICANN (both in GAC and the cross-community session). Progress within the Next-Generation Registration Directory Service (RDS) PDP WG will also be addressed. The WG is trying to reach consensus on questions concerning RDS users and purposes (who needs each data element and why?), access (control or publish data elements?) and privacy (applicability of data protection and privacy laws). The WG commissioned independent legal counsel on the impact of the GDPR on RDS and came up with a three-column document answering the WG's questions and deriving principles from these answers. In October, the first (of a series of) memorandum on the GPDR's impact on ICANN has been published. Here you can find more information about what has been done on data protection and privacy at ICANN.

Public Safety Working Group (PSWG)

At the time of writing, no (draft) agenda of the meeting was available. However, the PSWG is usually quite interesting, covering horizontal aspects, such as abuse mitigation, law enforcement access, data protection, etc., that span across a multitude of ICANN committees and policies.

Human Rights and International Law Working Group Meeting

The so-called "core values" in ICANN's <u>bylaws</u> include a reference to the respect of internationally human rights – the exact definition of which is subject to a framework of interpretation. The GAC aims to provide "potential advice to the Board on its use of Ruggie Principles as a tool "in the context of implementing this "core value". The "<u>Ruggie Principles</u>" (named after the Special UN Representative, John Ruggie) refer to the United Nations Guiding Principles on Business and Human Rights, a global standard aimed at preventing and addressing adverse impacts on human rights in the context of business activities (e.g. contractors using unpaid or child labour, etc.). Their applicability to operations within ICANN are controversial.

GAC Underserved Regions WG Meeting


The ccNSO has continued its work on the "Frequently Asked Questions About ccTLDs" document, which it intends to share with the GAC Underserved Regions WG ahead of ICANN60. The FAQ is scheduled for discussion in and endorsement by the GAC WG (and subsequently by the GAC). It is also likely to be discussed during the joint GAC-ccNSO meeting. The FAQ is not specifically mentioned in the context of the capacity-building workshop that will take place on Saturday.

Operational matters

The GAC will get a new leadership with Thomas Schneider stepping down as Chair and two new Vice-Chairs to be elected. The new leadership team will have its first meeting at the end of ICANN60. The GAC will continue discussions on an independent secretariat, the future of which is unclear, since the GAC were not able to secure funding for it. Workload (i.e. participation in PDPs and working groups) also remains an issue. The GAC seems reluctant to delegate individuals to cross-community working groups, as they are normally not in a position to make statements on behalf of the GAC.
